The due dates of GST returns have been changed or modified in some cases by the Central Government vide notifications 51 to 57/2020, dated 30/06/2020.

Do note that the relaxation/waiver is given for late fees and interest as stated hereunder, however, the due dates remain the same. We request you to kindly take the same on record and prepare the data for filing GST returns accordingly.
